

ELECTRONIC COMMUNICATIONS CONSENT

1. Consent

You hereby provide your consent ("Consent") to us providing you with any information, notices or disclosure and other information, including periodic statements, change of terms, privacy, and adverse action ("Communications") by electronic means, including in connection with your use of online services for an Account that may be available, from time to time, on our website ("Online Service").

2. Method of Communications

3. Manner of Consent

You agree that by giving your Consent through this website, you demonstrate that you can access information that we may provide to you by posting electronic Communications on a website.

4. How to Withdraw Consent

- A means to print or electronically store information through your browser software
- A personal computer or other device capable of connecting to the Internet that supports the foregoing requirements
